

Mental Health EPR Deployment (Trust and County Council)





Humber Teaching Hospital Extending SystmOne to Mental Health Services



- The Trust has **used SystmOne in Adult and Children's** Community Physical Health Services for several years
- Migrating MHS from Lorenzo to SystmOne enables the creation of a single EPR as a key element of Digital Strategy and Transformational Change
- Process standardisation and clinical document rationalisation is a key element of the project and Apira have supported these objectives through detailed Process Mapping and support for change in all Divisions
- Trust has adopted a 'Land and Expand' approach through an initial Minimum Viable and Safe Product and a commitment to subsequent Optimisation to fully achieve Board-defined Strategic Change Drivers included in the EPR FBC

Humber Teaching Hospital Extending SystmOne Use – Optimisation Phase



- Apira is providing support to start SystmOne
 Optimisation activities for Community Physical Health Services in parallel with the migration of MHS
- The stated Strategic Change Drivers provide the context for the Optimisation work, which includes implementation of other Strategic Digital applications such as a Patient Portal
- Priorities include standardisation of SystmOne driven processes/functionality and early benefits of single EPR, especially in Children's services
- Optimisation work will include pilot use of SystmOne functionality excluded from the EPR MVSP such as Brigid and Visualisation, as well as applications such as the AcurrX Patient Portal to improve patient and staff experience
- The pilots will inform use of these elements in MHS

- Delivered a fast-track deployment from Carenotes to Systm1 in 5 months:
 - Worked with a partner (Restart) to develop an Archive Viewer to provide access to legacy data without a traditional data migration
 - Programme Managed the accelerated deployment with extensive engagement into the clinical services to deliver core functionality
 - Expanded into Devon County Council to deploy S1 for the health and Social Care services that they are responsible for delivering.
